



## Awards Call for Nominations

RMEL is currently seeking nominations for the Distinguished Leadership Award, the Industry Leadership Award and Honorary Life Membership Award.

**Distinguished Leadership Award:** Awarded as merited to an employee of an RMEL member company who has demonstrated singular dedication, service, and leadership to the electric utility industry and has been active and supportive of RMEL in a noteworthy and particular way. The person must be active in the field at the time of the award.

**Industry Leadership Award:** Awarded as merited to an individual who has demonstrated singular dedication, service, and leadership to the electric utility industry. The person must be active in the field at the time of the award.

**Honorary Life Membership Award:** Honorary membership in RMEL shall be conferred upon individuals, at least 55 years of age, retired from a current or former RMEL member company. Individuals recognized shall be a person acknowledged in the electrical field, or one recognized for cooperative endeavor within the electrical industry or for long and valuable service to RMEL. Honorary Life Members shall have all the privileges of RMEL membership except that of holding office and shall be exempt from the payment of dues.
